We maintain information about you in order to provide you with the most effective and convenient access to our broad range of products and services. We want you to understand what information we collect and how we use and protect it.

COLLECTING YOUR INFORMATION

We collect and maintain information so that we can provide you with insurance coverage and other products and services. We may collect information about any business you have with us, our affiliates, or other companies. These affiliates have implemented privacy policies and procedures that comply with applicable federal and state law.

You may visit Gulf Guaranty's website without revealing your identity or any personal information. We do not collect any personally identifiable information about you without your knowledge. The only personal information we retain is the information you explicitly provide us when you fill out a form or sign up for service on this site.

USING YOUR INFORMATION

We use the information we collect online to process your request for services, products or information. How we use this information depends on the products and services you request from us.

PROTECTING YOUR INFORMATION

Our Security Procedures maintain the security of our customer information. We maintain physical, electronic, and procedural safeguards to guard information. We restrict access to your personal and account information to persons who need to know that information to provide you products or services or to vendors under contractual confidentiality agreements who assist us in operating and maintaining our websites. This notice serves as a standard for all Gulf Guaranty employees for collection, use, retention and security of nonpublic personal information.

Except as required by law or court order, we will not release any information that you provide us to any other third party.

We use "cookies" to help you personalize your online experience. A cookie is a small text file that is placed on your hard disk by a web server. Cookies are not used to run programs or deliver viruses to your computer. One use of cookies is to save you time by telling the web server that you have returned to a specific page that you previously visited. For example, if you complete a form on one of our web pages, a cookie helps us to recall the information you provided on subsequent visits so that you do not have to enter it again. You have the ability to accept or decline cookies. Most web browsers include settings to enable you to manage or decline cookies.

To assist us in maintaining and improving this website, we use Google Analytics to gather information about visitors' usage of the website through the use of cookies that provide us information that helps us improve the performance of this website for you. Google Analytics does not track, collect or upload any data that personally identifies an individual (such as a name, email address, account number or billing information), or other data which can be reasonably linked to such information. For example, it lets us track how many visitors the website has, which pages they spend time on, what kinds of operating systems and mobile devices they use, and how they found the website.
